Terms and Conditions

1) PAYMENT AND BILLING

- i) NOTN will bill client based on contract decisions
- ii) Invoices shall be based on commercials aired
- iii) Client can not be more than two weeks delinquent or advertisement will be suspended
- iv) Rates are not changeable without a revision of contract

2) TERMINATION

- i) If client cancels contract, NOTN will immediately bill based on all programs aired. If station cancels contract, client shall have credit due of the amount remaining on the original contract, to be paid in advertising time.

3) FAILURE TO BROADCAST

- i) If due to public or emergency necessity, restrictions imposed by law, acts of God or any other cause, including mechanical or electrical breakdowns beyond the control of NOTN and there is an interruption or omission of any advertisement broadcast contracted to be broadcast hereunder, then the client will not be responsible for that particular advertisement.

4) EFFECTS OF BREACH

- i) NOTN reserves the right to cancel this contract upon default by client in the payment of bills or other material breach of the terms thereof. Upon cancellation, all charges for broadcast completed hereunder and not paid shall become immediately payable.
- ii) In the event material breach by NOTN in performing the contract, the client reserves the right to cancel this contract at any time.

5) BROADCAST LIABILITIES

- i) NOTN agrees to hold and save client harmless against all liability resulting from the broadcast of program material except from program material furnished by client.
- ii) NOTN is harmless against all liability resulting from the broadcast of commercial and material or program material furnished by the client.

6) GENERAL

- i) NOTN shall exercise normal precautions in handling of property and mail, but assumes no liability
- ii) This contract contains the entire agreement between both parties and provisions shall be made in writing.
